Registration:

Check in from 2 p.m Every camper must contact the groundskeeper upon arrival before setting up Register and fill out the official registration form and one from the groundskeeper ID to be specified (ID card, identity card, etc.), upon request must be presented or deposited. Visitors must register and pay at reception.

Check out by 10 a.m Young people under the age of 16 can only do so when accompanied by someone responsible for them. only adult access. The bodies of Remo Camping have the right to limit the number of caravans users and their length of stay at any time. These regulations apply equally to tenants and visitors.

Taxes:

The use of the space is subject to a fee. Camping taxes are due immediately upon request, but no later than the evening before To pay departure. If you depart after 10 a.m., an additional fee is charged Daily tax to be paid.

Space allocation, vehicles:

The number of parking spaces is limited. The site is allocated to the campers by the groundskeeper. The space available to the camper is limited to that of a motorhome or a caravan required area, No awnings or carpets are permitted. Vehicles must be in the allocated space or in a specially designated place. in the right open space. The neighbors must not be restricted or hindered in their access and exit become. The paths throughout the area must always be kept clear.

Between 10 p.m. and 5 a.m. and from 12 p.m. to 2 p.m. every driver is vehicle traffic within the campsite is prohibited. The speed on the pitch is limited to 10 km/h. Leaving unoccupied campers and caravans is subject to a fee. Required and only permitted with the consent of the groundskeeper.

Rest times:

Excessive noise should also be avoided during the day. Radios and televisions should be set to room volume. **The rest period from 10 p.m. to 7 a.m. and from 12 p.m. to 2 p.m. is strict To comply,** music and any other type of noise are not allowed in the neighborhood disturb.

Pets:

Pets may only be kept on a short leash on the site. Carrying out your needs on the campsite is prohibited. Animals are not allowed to roam freely. The owner is liable for any pollution caused by pets.

Dogs must always be kept on a leash and must be kept on a leash the whole area.

Sanitary and other space installations:

All systems are only intended for their intended purpose use and only for our camping guests. The sanitary facilities are always in working order to leave in a state of disrepair. The entire campsite is clean and to be left in a tidy condition. The waste water and the contents of portable toilets may only be disposed of in this area certain drains must be emptied. It is strictly forbidden in this basic water zone to allow wastewater to seep into the ground. Own water and sewer connections can be approved if required but in any case the consent of the officially responsible building authority, which each Remove or remove the system before commissioning. must control. **Grilling is permitted but only with gas or electric grill. No fire, no wood coal etc.**

Stems and permanent installations:

All buildings for long-term tenants require approval and must be approved by the building authorities. to the authority and may only be submitted with the prior consent of the groundskeeper. tes can be created. Additions are expressly subject to the authority of the site manager waits on behalf of the building authority to which he is responsible. For this reason its guidelines must be followed. The gas installations must comply with legal regulations and are per- odic and can be checked at any time by a gas specialist (canton/city). my opinion). Every building needs a fire alarm and must be insured. **A residence name is not possible.**

General provisions:

It is the tenant's responsibility to take out appropriate private insurance. Anyone who does not adhere to order, peace, cleanliness, mutual consideration, etc. as respects decency and good morals, will be immediately expelled from the seat. Games on the pitch are only permitted if they are harmless and the other The campers will not be disturbed by this. It is not permitted to operate any business on the camping area, To offer goods for sale or to use the property in any other way for business purposes use or rent out.

House rules:

Presence on the campsite constitutes tacit acknowledgment the site regulations and public regulations. The place management can take measures to comply with the site rules, can be responsible of damage and guests and tenants if the site regulations are not adhered to. to be sent off the pitch.
